## 10. Church update

The Chairman informed the meeting that he was very disappointed with the Church regarding the organisation of the recent public meeting. It was noted that the Parish Council had been asking for a public meeting for over a year and nothing had been arranged until a decision had been made on the outcome of the tower rendering. Concern and upset was raised by a local family who have a wedding planned for August and have been told that there will be scaffolding and blue sheeting around the tower structure. It would appear that no communication had been made to the family when the wedding was booked. The Clerk was asked to write to the Parochial Church Council expressing the concerns of the Parish Council. The Clerk to contact YDNP to ask that the Parish Council be consulted on the colour of the rendering.

## 11. Playground

Resident, Mr Garside, kindly tidies up the debris etc in the playground and has planted a wild flower corner. It was noted that areas of the wet pour will need replacing at a later stage.

Mrs Annison gave an update on public transport and gave out timetables for the Northern Dales Bus 858 which operates on a Sunday from 5<sup>th</sup> Ma – 20<sup>th</sup> October and passes through Askrigg.

**17. Vehicle Activation Sign**

The Clerk circulated data from the speed matrix. The highest speed reported was 55.8 mph in a 30mph area outside the primary school. The Police were in attendance at the meeting a reported that they would be operating the speed gun on Station Road over the next couple of weeks.
